Management Discussion of Fund Performance

Results of Operations

Renaissance Global Growth Fund's (referred to as the *Fund*) portfolio sub-advisor is Walter Scott & Partners Limited (referred to as the *Sub-Advisor*). The commentary that follows provides a summary of the results of operations for the six-month period ended February 29, 2024. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 13% during the period, from \$3,624,039 as at August 31, 2023 to \$4,111,670 as at February 29, 2024. Net sales of \$45,939 and positive investment performance resulted in an overall increase in net asset value.

Class A units of the Fund posted a return of 11.3% for the period. The Fund's benchmark, the MSCI World Index (referred to as the *benchmark*), returned 13.0% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

Global stock markets finished 2023 strong as retreating inflation raised hopes of faster-than-expected monetary policy easing. Subsequent central bankers' comments and ongoing US economic resilience forced investors to reappraise the outlook for interest rate cuts. However, momentum in equity markets was maintained by continued excitement around artificial intelligence (referred to as *AI*).

US personal consumption defied predictions that higher interest rates and rising prices would crimp spending. A resilient jobs market continued to provide a positive backdrop for consumer incomes. A lower rate of inflation also helped sentiment.

Europe continued to battle with economic weakness, but labour market tightness helped to bolster personal consumption to some extent.

Chinese equity markets were weak over the period. Despite some tentative measures aimed at stimulating activity, the government did not impose stronger measures to foster faster growth. Post-pandemic economic recovery continued to be lacklustre, with attention focused on concerns in the real estate market and deflationary pressures. The country's stock market did stage a strong rebound in February, however,

bolstered by domestic trading activity and some positive holiday consumption and travel data.

Exposure to the US detracted from the Fund's performance, as did exposures to the financials and information technology sectors. The largest individual detractors from the Fund's performance were overweight holdings in Prudential PLC, Cisco Systems Inc. and AIA Group Ltd. Prudential's share price was weighed down by ongoing macroeconomic concerns around China. Cisco Systems was negatively affected by a larger-than-expected decline in new product orders and a reduced outlook for the year. Its customers are currently focused on installing and implementing products in their environments following exceptionally strong product delivery over the last three quarters. AIA Group's share price continued to reflect general macroeconomic concerns regarding China, despite the company's strong momentum and record third-quarter premiums.

The Fund's exposures to the consumer staples, materials and health care sectors contributed to performance. Top individual contributors to performance included overweight holdings in Taiwan Semiconductor Manufacturing Co. Ltd. (referred to as *TSMC*), Novo Nordisk AS and Costco Wholesale Corp. TSMC, along with others in the semiconductor industry, had a strong 2023 amid a cyclical recovery and enthusiasm toward AI investment. Novo Nordisk's share price rose given the strong performance of its glucagon-like peptide 1 products. Costco Wholesale delivered good results, with its success driven by consumer loyalty and market share gains across all categories.

The Sub-Advisor added a new holding in ASML Holding NV based on its leading market position in lithography equipment for the semiconductor industry. Mettler-Toledo International Inc. was also added to the Fund, given its focus on innovation and reputation for quality, accuracy and reliability. Mettler-Toledo has consistently grown revenues and improved profitability.

Existing holdings in Edwards Lifesciences Corp., Moody's Corp. and O'Reilly Automotive Inc. were increased. Edwards Lifesciences was increased to take advantage of a lower share price. The Sub-Advisor believes that Moody's long-term growth should be driven by global corporate earnings, which supports bond issuance, pricing initiatives

and Moody's fast-growing analytics franchise. O'Reilly Automotive was increased for its recessionary-resilient qualities and strong share gains. The business appears well placed to continue consolidating a highly fragmented market while returning significant cash to shareholders.

Illumina Inc. was eliminated from the Fund as the company is involved in protracted legal process with antitrust regulators following its acquisition of Grail Inc. A holding in KONE OYJ was sold as its growth has been impacted by a construction downturn, particularly in China, its largest market. The Sub-Advisor sold Cognex Corp. following disappointing fundamental performance driven by the slowdown in global industrial activity and a reduction in demand from some significant customers.

Novo Nordisk and Shin-Etsu Chemical Co. Ltd. were trimmed following strong share price performance. A holding in Booking Holdings Inc. was also trimmed after strong performance amid a strong rebound in travel. Although the company's outlook remains healthy, current rates of growth may slow over time and, as such, macroeconomic uncertainty led the Sub-Advisor to trim the holding.

Recent Developments

The level of geopolitical risk disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the Fund's performance. The Manager continues to monitor ongoing developments and the impact to investment strategies.

Related Party Transactions

Canadian Imperial Bank of Commerce (referred to as *CIBC*) and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*.

The Manager pays the Fund's operating expenses (other than certain fund costs) in respect of the classes of units of the Fund (except Class O unit), which may include but are not limited to, operating and administrative costs; regulatory fees; audit, and legal fees and expenses; trustee, safekeeping, custodial, and any agency fees; and investor servicing costs and costs of unitholder reports, prospectuses, Fund Facts, and other reports, in exchange for the Fund paying a fixed rate administration fee (plus applicable GST/HST) to the Manager with respect to those classes of units. For Class O units, no fixed administration fee will be charged. The Manager pays the Fund's operating expenses (other than certain Fund costs) allocated to Class O units of the Fund. The fixed administration fee payable by the Fund,

may, in any particular period, exceed or be lower than the expenses we incur in providing such services to the Fund.

As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Securities Inc. (referred to as *CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC SI, CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor or any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor or any portfolio sub-advisor(s) to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor or any portfolio sub-advisor(s) when they process trades through them. These types of goods and services for which the Portfolio Advisor or a portfolio sub-advisor may direct brokerage commissions are research goods and services and order execution goods and services, and are referred to in the industry as "soft-dollar" arrangements. These goods and services received through soft dollar arrangements assist the Portfolio Advisor or any portfolio sub-advisor(s) with investment decision-making services for the Fund, or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio advisory agreement and portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable

and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (referred to as the *IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer* or the *Related Dealers*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the Private Placement Relief Order and the policies and procedures relating to such investment);
- purchase equity or debt securities from, or sell them to, a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a related party is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate (referred to as *inter-fund trades* or *cross-trades*); and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (referred to as the *Custodian*). The Custodian holds cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian are paid by the Manager. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company Inc. (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager. CIBC indirectly owns a 50% interest in CIBC GSS.

⁵ Management expense ratio is based on the total expenses of the fund (excluding commissions and other portfolio transaction costs), incurred by or allocated to a class of units for the period shown, expressed as an annualized percentage of the daily average net asset value of that class during the period. The management expense ratio includes the fees attributable to exchange traded funds.

⁶ The decision to waive management fees is at the discretion of the Manager. The practice of waiving management fees may continue indefinitely or may be terminated at any time without notice to unitholders. The management expense ratio before waivers or absorptions includes the fees attributable to exchange traded funds, where applicable.

⁷ The trading expense ratio represents total commissions and other portfolio transaction costs before income taxes expressed as an annualized percentage of the daily average net asset value during the period. Spreads associated with fixed income securities trading are not ascertainable and, for that reason, are not included in the trading expense ratio calculation. Previously, the trading expense ratio included the fees attributable to exchange traded funds which are now no longer included in the TER. Prior year fees attributable to exchange traded funds have been reclassified to the management expense ratio and management expense ratio before waivers or absorptions.

⁸ The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisor are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

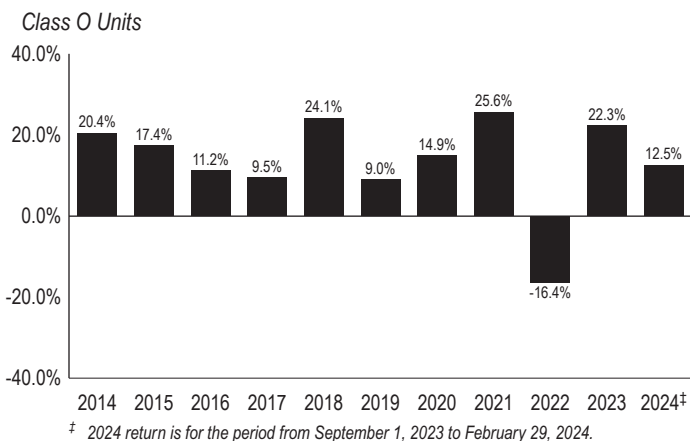
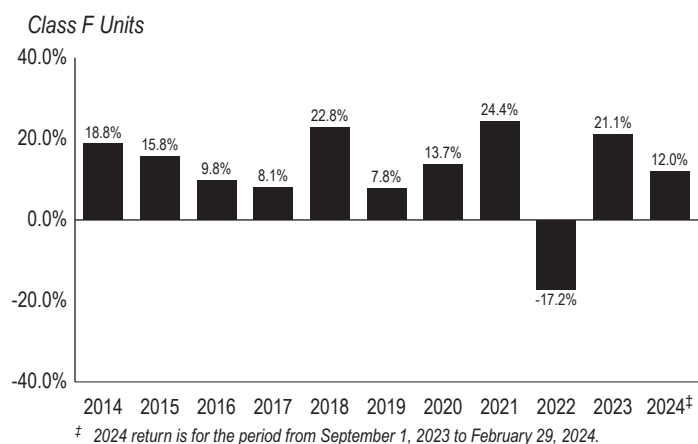
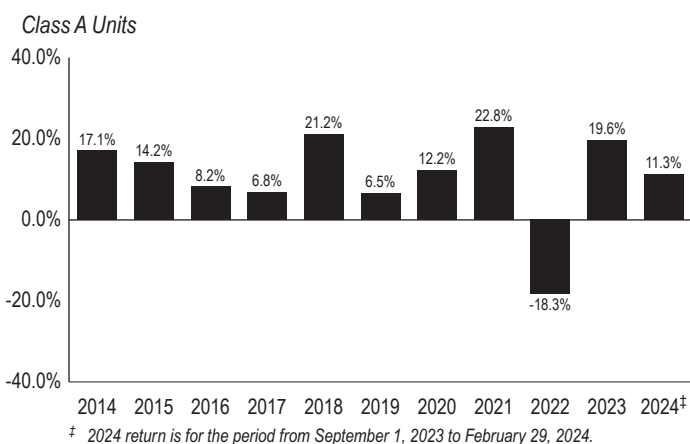
Past Performance
