### Management Discussion of Fund Performance

#### Results of Operations

Renaissance International Equity Currency Neutral Fund's (referred to as the Fund) portfolio advisor is CIBC Asset Management Inc. (referred to as CAMI, the Manager, or the Portfolio Advisor). The Fund primarily invests in units of Renaissance International Equity Fund (referred to as the Underlying Fund).

The Fund attempts to reduce its currency exposure to non-Canadian dollar currencies by implementing a currency hedging strategy that is aimed at protecting the Fund from non-Canadian dollar currency fluctuations in respect of units it owns in the Underlying Fund. The Fund may not be able to hedge its currency exposure fully and therefore could be subject to some foreign currency exposure.

The Underlying Fund's portfolio Sub-Advisor is Walter Scott & Partners Limited (referred to as the Sub-Advisor). The commentary that follows provides a summary of the results of operations for the six-month period ended February 29, 2024. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 33% during the period, from \$42,963 as at August 31, 2023 to \$57,327 as at February 29, 2024. Net sales of \$8,186 and positive investment performance resulted in an overall increase in net asset value.

Class A units of the Fund posted a return of 11.6% for the period. The Fund's benchmark, the MSCI EAFE Index (local currency) (referred to as the benchmark), returned 9.9% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

Hopes that central banks had reached the end of interest rate tightening cycles pushed many international stock markets sharply higher over the period.

European economic data was lacklustre but not as weak as many observers had originally feared. Inflation continued to fall, boosting hopes of more accommodative monetary policy and a brighter outlook for the hard-pressed consumer.

China's economy showed few signs of escaping its tepid performance. A debt-laden real estate sector, deflationary pressures and weak economic activity combined to keep investors on the sideline. However, there was a notable recovery in share prices in February.

Japanese equities continued to rebound, with the Japanese stock index reaching an all-time high. A weak yen, inflows from a just-launched government-subsidized savings scheme for domestic investors, an equity valuation catch up, and hopes for better corporate reform momentum continued to underpin the market.

Exposures to Europe (excluding the UK) and the health care sector contributed to the Underlying Fund's performance over the period. An overweight allocation to the information technology sector also contributed to performance. Individual contributors to performance included overweight holdings in Taiwan Semiconductor Manufacturing Co. Ltd. (referred to as TSMC), Shin-Etsu Chemicals Co. Ltd. and Novo Nordisk AS.

TSMC, along with others in the semiconductor industry, had a strong 2023 amid a cyclical recovery and enthusiasm toward artificial intelligence investment. Shin-Etsu Chemical's strong performance was a result of strength in semiconductor-related stocks as a whole, and also its polyvinyl chloride-led infrastructure business. This business unit has been enjoying high profits recently amid strong housing demand, low input prices, industry consolidation and a favourable price for caustic soda, which is a major byproduct for Shin-Etsu Chemical. Novo Nordisk's share price rose given the strong performance of its glucagon-like peptide 1 products.

The Underlying Fund's allocations to the financials and industrials sectors detracted from performance, as did exposure to Japan. The largest individual detractors from the Underlying Fund's performance were overweight holdings on Prudential PLC, Daikin Industries Ltd. and Jardine Matheson Holdings Ltd. Prudential's share price was weighed down by ongoing macroeconomic concerns around China. Daikin Industries was impacted by the weak macroeconomic environment, particularly the property downcycle in China, as well as negative sentiment around China. Jardine Matheson Holdings' share price

continued to decline as a result of negative sentiment toward China and Hong Kong.

A new holding in Amadeus IT Group SA was added to the Underlying Fund. The company owns the top passenger service system globally, exposing it to the long-term growth in air passenger traffic. Wolters Kluwer NV was added to the Underlying Fund for its accelerating organic sales growth. A new holding in Universal Music Group NV was added as music has seen a strong resurgence following the advent of streaming, and there are other trends that may drive healthy future growth.

Existing holdings in OBIC Co. Ltd. and Merck KGaA were increased. OBIC should benefit from structural growth in technology investment across corporate Japan, as well as in cloud-computing software. Merck was increased during a period of weak share price performance. The Underlying Fund's Sub-Advisor is confident in the company's long-term prospects and the recovery in the bioprocessing market.

The announcement of Christian Hansen Holdings AS's intention to merge with Novozymes AS led to increased uncertainty. The size of the deal brings integration risk, and the delivery of longer-term revenue and profit acceleration is far from certain. As a result, the Underlying Fund's Sub-Advisor eliminated both holdings from the Underlying Fund. Sandoz Group AG, which was spun out from Novartis AG, was eliminated from the Underlying Fund.

Holdings in Novo Nordisk, Cochlear Ltd. and Shin-Etsu Chemical were trimmed after strong share performance

### Recent Developments

The level of geopolitical risk disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the Fund's performance. The Manager continues to monitor ongoing developments and the impact to investment strategies.

### Related Party Transactions

Canadian Imperial Bank of Commerce (referred to as *CIBC*) and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

#### *Manager, Trustee, and Portfolio Advisor of the Fund*

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*.

As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection

with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

#### *Distributor*

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Securities Inc. (referred to as *CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC SI, CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

#### *Brokerage Arrangements and Soft Dollars*

The Portfolio Advisor or any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor or any portfolio sub-advisor(s) to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor or any portfolio sub-advisor(s) when they process trades through them. These types of goods and services for which the Portfolio Advisor or a portfolio sub-advisor may direct brokerage commissions are research goods and services and order execution goods and services, and are referred to in the industry as "soft-dollar" arrangements. These goods and services received through soft dollar arrangements assist the Portfolio Advisor or any portfolio sub-advisor(s) with investment decision-making services for the Fund, or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio advisory agreement and portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

#### *Fund Transactions*

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the

standing instructions issued by the Independent Review Committee (referred to as the *IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer* or the *Related Dealers*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the Private Placement Relief Order and the policies and procedures relating to such investment);
- purchase equity or debt securities from, or sell them to, a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a related party is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate (referred to as *inter-fund trades* or *cross-trades*); and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

#### *Custodian*

CIBC Mellon Trust Company is the custodian of the Fund (referred to as the *Custodian*). The Custodian holds cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian are paid by the Manager. CIBC owns a 50% interest in the Custodian.

#### *Service Provider*

CIBC Mellon Global Securities Services Company Inc. (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager. CIBC indirectly owns a 50% interest in CIBC GSS.

<sup>7</sup> The trading expense ratio represents total commissions and other portfolio transaction costs before income taxes expressed as an annualized percentage of the daily average net asset value during the period. Spreads associated with fixed income securities trading are not ascertainable and, for that reason, are not included in the trading expense ratio calculation. Previously, the trading expense ratio included the fees attributable to exchange traded funds which are now no longer included in the TER. Prior year fees attributable to exchange traded funds have been reclassified to the management expense ratio and management expense ratio before waivers or absorptions.

<sup>8</sup> The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

**Management Fees**

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

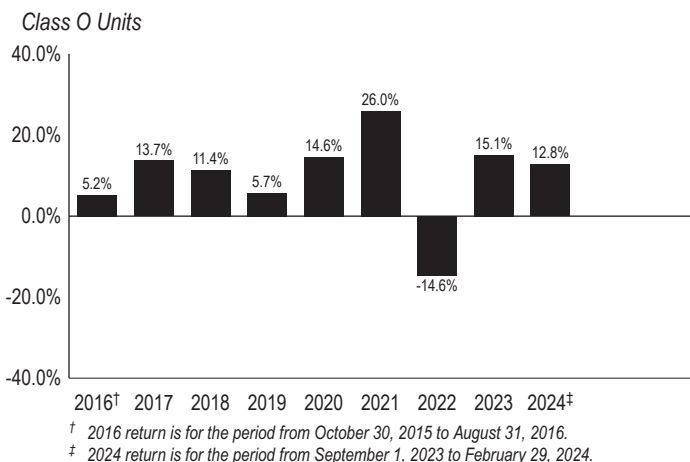
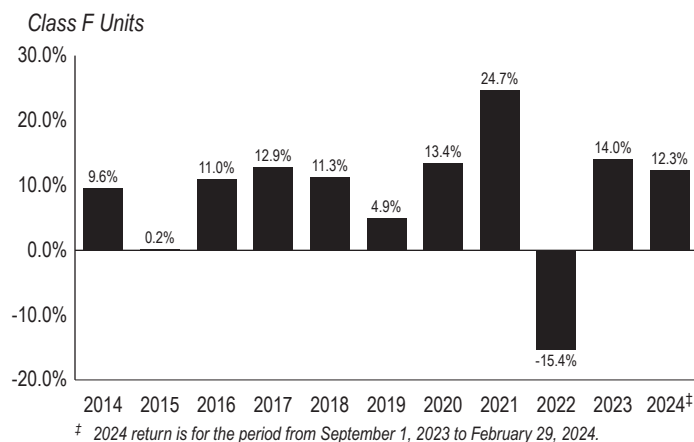
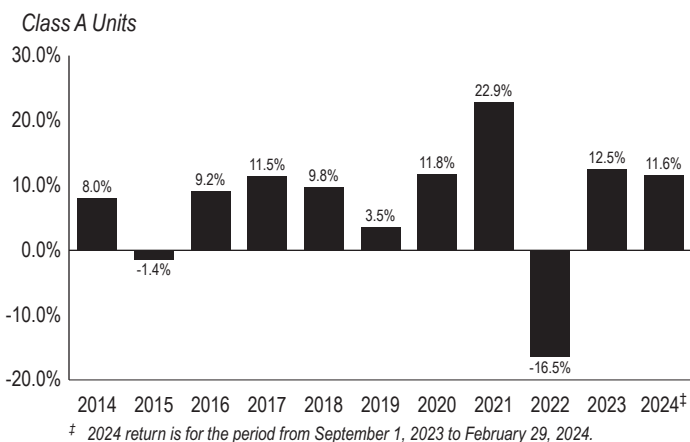
### Past Performance
